


BIELSDOWN PROJECT STATUS

BLICKS GOLD PROJECT

EL 6465 - Anchor 100%

- 70 km west of Bielsdown
- Interpreted as large reduced intrusion-related gold system
- Deposit class not recognized at discovery in 2000
- Similar style deposits are Fort Knox, Pogo, Donlin Creek (Alaska) & Kidston

BLICKS GEOLOGICAL MODEL




FIGURE General plan model of RIRGS from the Tintina Gold Province. Of note are the wide range of mineralization styles and geochemical variations that vary predictably outward from a central pluton. Scale is dependent on the size of the exposed pluton, which is likely to range from 100 m to 5 km in diameter. Modified from Hart et al. (2002).

BLICKS PAST EXPLORATION

- Two gold in soil geochemical anomalies defined at Tyringham East & West
- Historic RC drilling partially tested these anomalies

 Encouraging gold results in 9 of 11 holes drilled (e.g. TRC-02 75m @ 0.2g/t Au)

BLICKS PROJECT STATUS

- 2011 Anchor plans to drill 2 deep oriented diamond core holes to test down dip continuity
 - Potential for discovery of higher grade mineralization

BIRDWOOD COPPER/MOLYBDENUM PROJECT EL 6459 – Anchor 100%

BIRDWOOD PAST EXPLORATION

- Tested in 1960's with 9 diamond core holes
- Best result 12.8 m @ 0.79% Cu 4.9 g/t Ag
- Visible molybdenite recorded at numerous locations on surface and values up to 1,000ppm in core

BIRDWOOD STATUS

 Anchor planning deep diamond drilling program to evaluate the extent of the poorly tested porphyry system


ANTIMONY DEMAND
